

# Privacy Policy

Protecting your private information is our priority. This Statement of Privacy applies to <https://www.bowmansboutiquellc.com>, and Bowman's Boutique, LLC and governs data collection and usage. For the purposes of this Privacy Policy, unless otherwise noted, all references to Bowman's Boutique, LLC include <https://www.bowmansboutiquellc.com> and Bowman's Boutique. The Bowman's Boutique website is a Sale of accessories, clothing and other apparel. site. By using the Bowman's Boutique website, you consent to the data practices described in this statement.

## Collection of your Personal Information

In order to better provide you with products and services offered, Bowman's Boutique may collect personally identifiable information, such as your:

- First and Last Name
- Mailing Address
- E-mail Address

We do not collect any personal information about you unless you voluntarily provide it to us. However, you may be required to provide certain personal information to us when you elect to use certain products or services. Bowman's Boutique may disclose your personal information, without notice, if required to do so

- Detect security incidents, protect against malicious, deceptive, fraudulent, or illegal activity; or prosecute those responsible for that activity;
- Debug to identify and repair errors that impair existing intended functionality;
- Exercise free speech, ensure the right of another consumer to exercise his or her right of free speech, or exercise another right provided for by law;
- Comply with the California Electronic Communications Privacy Act;
- Engage in public or peer-reviewed scientific, historical, or statistical research in the public interest that adheres to all other applicable ethics and privacy laws, when our
